

Potential Topics for Review

Telehealth and Transparency Bill Draft Requests

In addition to the identified topics, voting commissioners were asked if they wanted to further discuss specific components of either request (telehealth or transparency). They were also asked to provide any other recommendations for the commission to consider. The majority of the commission did not request further review on these topics.



Although Commissioner Bond and Commissioner Roa Dugan did not request further review of the transparency measure, both indicated transparency (see topic #5) as a top priority for further review.

Commissioner Slonim and Commissioner Flo Kahn did not identify topic #5 as a top priority but both indicated they would like for the commission to review and further discuss the transparency measure specifically related to components of an All Payer Claims Database. Furthermore, Commissioner Flo Kahn would like for the commission to consider a modification to the confidentiality provisions discussed during the August 31, 2020 meeting.

Commissioner Packham did not request review of specific components of either measure but requested for the commission to hold a discussion of draft language developed by the LCB on both measures.
