NRS 439.918(1)(c):

Establish, submit to the Director and annually update a plan to increase access by patients to their medical records and provide for the interoperability of medical records between providers of health care in accordance with the requirements of the Health Insurance Portability and Accountability Act of 1996, Public Law 104-191, and any other applicable federal law or regulations

Informational: 83rd Legislative Session Update Regarding PPC Bills (SB29, SB34 and SB40)



PPC 2025 Bills

<u>Referred to Senate Health and Human Services Committee</u>

- **SB 29** requires the development and implementation of a reimbursement system for services provided through accountable care organizations; requires a survey of healthcare providers participating in Medicaid; and increases Medicaid reimbursement rates for services provided by physicians and APRNs.
- SB 40 establishes the Medicaid Health Care Workforce Account. The Account would leverage federal Medicaid funds to support health care workforce initiatives, such as Graduate Medical Education (GME) programs in the state.


<u>Referred to Senate Commerce & Labor Committee</u>

 SB 34 – enacts interstate licensure compacts for nurses, physical therapists, audiologists and speech-language pathologists, occupational therapists and physician assistants.

Health Equity and Disparities

Nevada Performs Below Average in Health Equity and Disparities

Key Performance Indicators:

- 45th in Access and Affordability¹
 - 11.4% uninsured rate²
- **35th** in Racial and Ethnic Equity¹
 - Infant mortality rate (IMR) is 2x higher for babies born to black mothers³

Possible Focus Areas Identified in the 2025 PPC Priorities Survey: Access to Care

- Increase Access to Care for Uninsured Individuals
 - Support developing policies to address equitable access to essential services
 - Support initiatives to eliminate barriers to care

Disparities in Health Outcomes

- Decrease Disparities in Health Outcomes
 - Increase health literacy in underserved and marginalized communities
 - Increase culturally competent and age-appropriate care
 - Increase equitable access to routine preventative care and screening
- Increase Physical Access to Care
 - Transportation; Availability; Proximity; and Scheduling

Key Performance Indicators:

- **8.9%** growth¹
 - U.S. Avg. 7.1%
- 45th in Access and Affordability²
- 46th in Care Avoided Due to Cost³

Possible Focus Areas Identified in the 2025 PPC Priorities Survey: Pharmaceutical Pricing

- Pharmacy/Prescription Drug Costs
 - Evaluate growing costs and options to bend the cost curve
 - Promote transparency, affordability, and value in drug pricing
- Cost Transparency
 - Increase cost transparency by requiring manufacturers, PBMs and insurers to disclose pricing structures, rebates, and out-of-pocket costs
 - Analyze data concerning insurance claims to develop policies to improve patient access to quality and affordable care


